Delegations are informed that the written procedure, opened by CM 3649/26 of 25 August 2026, was completed on 27 August 2026 at 10:10.

All delegations, including the Commission, agreed to the use of the written procedure for the adoption of the following Council Implementing Decisions on the approval of the assessment of the recovery and resilience plans for Belgium, Bulgaria, Greece, Spain, Croatia, Italy, Cyprus, Latvia, Hungary, Poland, and Portugal, as set out, after the legal-linguistic revision, in the following documents:

All delegations voted in favour of the adoption of the above-mentioned Council Implementing Decisions on the approval of the assessment of respective recovery and resilience plans.

The required agreement of all the members of the Council and of the Commission to the use of the written procedure and the required qualified majority for the adoption of the Council Implementing Decisions have been reached. Therefore, the above-mentioned eleven Council Implementing Decisions are adopted, with Thursday, 27 August 2026 as the date of their adoption.

In line with the decision of the Permanent Representatives Committee of 9 July 2021, these Decisions will not be published in the Official Journal of the EU. These Decisions will enter into force when notified to the Member States concerned.
